It is understood that in the event of damage to the container or marble cargo, the port operator shall not be held responsible.</i></p> <p><i>In case of a request for dunnaging and/or other services in different standards, a written request must be made to the port operator to obtain confirmation of compliance and pricing.</i></p> <p><i>*The exporter's appointed inspection company is responsible for verifying and accepting that the container(s) to be loaded by QTerminals Antalya comply with CTU Code 4.2.2 and 4.2.3, are in good condition, suitable for loading, and have undergone the necessary periodic inspections.</i></p>
